Report from MG Larry Shellito

The current membership year is coming to a close. For those of us who have joined-thank you! What is concerning to me, however, is Minnesota's membership percent age in our state and national associations shows that nearly half of our eligible leader have not joined. There are clearly too many state and national issues that our associations need to address and without membership-i.e.financial support and involvement-we lose a window of opportunity to shape our future.

For all of us, the 2009 membership drive will begin shortly. I am fully aware of the demands placed on all of us for memberships. I can understand if you choose another organization that more fully meets your personal choice. I just ask that you give the National Guard Association consideration. The past several years I have seen significant evidence of the powerful role the NGAUS has played both nationally and in our state. The National Defense Authorization Act, for example, has given the National Guard a fourth star for our Chief. Improvements in the educational benefits are also noteworthy .Changes in retirement to include earlier benefit eligibility for those deployed also signals the changed attitude in congress towards the National Guard.

The 2008 National Guard Association's annual conference was recently conducted in Baltimore, MD. By all measures it was a very successful conference evidenced by a parade of notable speakers to include Senators McCain and Biden., Sec Def Gates, General Casey, and Veteran's Affairs Speaker Peakes. Their presence was continuing evidence that the National Guard has been recognized for its essential role in our nation's military structure. The National Guard's performance-whether at home or abroad-has shown all that we are a relevant, reliable, and ready force.

For the Minnesota National Guard this past year has been a benchmark year. Continued deployments and redeployments, the RNC

(a national security event), recruiting and retention success, and the maturing of our Deployment Cycle Support programs (reintegration) are all positive examines of continuous improvement. It is not uncommon to hear the phrase," it's good to be Minnesota!"

Warrant Officer Caucus Report

CW5 (ret) Walter Schulz and I attended the Warrant Officers Caucus while attending the 130th NGAUS General Conference in Baltimore MD. The main speaker was CW5 Emerst, NC CCWO and WOSAC Chair. CW5 Emerst spoke of the WO challenges and initiatives.

Some of the issues facing the WO Officer Corp are:

59% of Warrant Officers are eligible for retirement today.

We are at 70% of assigned strength.

The authorized strength of the Warrant Officer Corp is 9975 and we presently have 7025 Warrant Officers Assigned.

This is the first time we have exceeded 7000 Assigned Warrant Officers. Some good news is that we have exceeded YTD Recruiting Objective by 164 Warrant Officers.

Initiatives that we have working for us at this time are that DOD has funded Warrant Officer Recruiters for each State and Bonuses for Warrant Officer Retention.

The conference was both interesting and informative and I recommend more attendees at future conferences.

Law Changes: retirees now salute flag
Reprint from Army Echoes, September - December 2008, p3

Retired Soldiers are Still Proud! Congress has put Still Saluting into law for Retired Soldiers and other veterans. The 2008 National Defense Authorization Act (Public Law 110-181) changed...which covers "Conduct during hosting, lowering or passing of flag." "During the ceremony of hoisting or lowering the flag or when the flag is passing in a parade or in review, all persons present in uniform should render the military salute. Members of the Armed Forces and veterans who are present but not in uniform may render the military salute. All other persons present should face the flag and stand at attention with their right hand over the heart, or if applicable, remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart. Citizens of other countries present should stand at attention. All such conduct toward the flag in a moving column should be rendered at the moment the flag passes."

Membership

The membership of the National Guard Association of Minnesota continues to be of concern. While the rate of retired life state and national membership has stayed constant for many years (\$175 for lifetime membership), memberships trickle in. The 148th Fighter wing needs our support and the support of all military organizations as they struggle to find new aircraft to replace their aging fleet. They are preparing to deploy for the fourth time in three years, and with every inspection set new records of achievement. Let's help them by increasing the power of our voice at the National Level. The Wing will deploy 320 Airman in support of Operation Iraqi Freedom (OIF) between September 2008 and January 2009. The latest deployment is the Wing's fourth deployment of the "aviation package" to Iraq since 2005. In addition, individuals continue to support Operation Enduring Freedom and Air Expeditionary Forces operations around the world.

The 148th received numerous awards during the past six months. In June, Occupational Safety & Health Administration (OSHA) presented the Wing the Voluntary Protection Program (VPP) Star rating. The 148th FW is the first unit in the Air Force to earn the VPP Star rating, which demonstrates a measurable process to show excellence in occupational safety and health. In July, Lt Gen. Craig McKinley, Director Air National Guard, presented the Wing with the Air Force Outstanding Unit Award for demonstrating exceptional Meritorious service. Retired/Separated Caucus Meeting

Hello Retirees: I am happy to write a few lines about the Retired/Separated Caucus meeting that took place on 21 September during the 130th NGAUS conference in Baltimore, MD. Around 140 retirees and guests attended the session.

COL (Ret) Ray Magill, Retired/Separated Director-Air (MA) recognized the efforts of the Maryland Retiree Committee in sponsoring the Conference Retired /Separated Luncheon and Caucus meeting. He also introduced special guests in attendance including: past and present NGAUS Directors and Executive Committee members, as well as former TAGs. COL (Ret) Don Deering (TN) was elected to a 3-year tour as Retired/Separated Director-Army. (COL (Ret) Ray Magill term expires in 2010.)

The guest speaker was COL (Ret) Pete Duffy, Deputy Legislative Director for NGAUS. He called on Retirees to take a more active role in assisting to lobby

Congress for retired issues. He talked about this year's successful defeat of legislative efforts to raise TRICRE premiums.

Beginning on 28 January 2008, age 60 retirement can be reduced by three months for each aggregate of 90 days in support of a contingency operation. Next year's legislative efforts will continue to work to make this early retirement provision retroactive to 2001. Focus will also be on authorizing Gray Area Retirees to purchase TRICARE Standard at government cost. Pre-deployment medical/dental coverage is currently available for our ready reserve members starting at 90-days prior to mobilization. NGAUS will work to advance these benefits to begin with receipt of the Training Alert order. This should provide more responsive pre-deployment medical support, especially with dental care issues. Sen. Chamblis of GA was recognized for his exceptional support in sponsoring many National Guard friendly legislative initiatives. The Housing Rescue bill contains provision to extend the 6% interest cap for 1 year post-deployment and calls for no foreclosures for 9 months post-deployment. VA health care is now extended for 5 years (vs. 2 years) post-deployment of a combat tour. There is a strong push to improve behavioral health programs. NGAUS will host a Mental Health Accessibility Roundtable panel on 9 October at the National Guard Memorial Building in DC.

Your Minnesota delegation to the 130th NGAUS General Conference included 12 Air and Army retirees. By the way if you are not a paid up for life member of NGAUS, please consider doing so. The cost is a reasonable, one-time, \$125.
